Definition and implementation of a configuration prototype of the converted system to match the changed standard functionality of FinanceKIT 6.x, and new or streamlined functionality as required by the ECB. Development of an automated test tool (input of test cases, calculation of expected results) that could be re-used and further developed by the ECB for the acceptance test of FinanceKIT 6.x and the regression test of forthcoming FinanceKIT versions.

Automated regression test of the migrated system, according to the ECB test conditions, preferably at the Trema office in Frankfurt.

Development of a technical 'turn-key' FKIT 6.x installation, conversion and re-configuration package for the ECB system.

Throughout the entire process described above it will be the duty of the contractor to liaise with the software vendor Trema to deal with upcoming issues.

Some support for the ECB's acceptance, final conversion and technical performance3 tests, and for the go-live.
