The European Central Bank (ECB) is planning to construct its new premises on a site of approximately 120 000 m^2 in Frankfurt-on-Main, Germany. The ECB has already commissioned an architect to provide the architectural planning, the structural engineering and an energy design concept, and a planning team consisting of special planners for specific areas. Further to the planners already commissioned, the ECB intends to award a contract for consultancy services for blast mitigation and non-progressive collapse for the new ECB premises under a negotiated tender procedure.
