- II.1.6) Description/object of the contract:

The European Central Bank (ECB) is planning to construct its new premises in Frankfurt-on-Main, Germany. For this purpose the ECB has conducted an architectural competition and awarded the first prize to the design concept of COOP HIMMELB(L)AU, Vienna (Austria). The Project has now entered the planning phase, where the architect and special planners refine the prize-winning design. As part of the planning process, and on the basis of the current status of the façade planning, the ECB intends to award a contract on the construction of a 3-dimensional mock-up façade model including different types of façade in a limited tender procedure (3-quote

procedure according to the ECB procurement rules).

In order to establish a shortlist of qualified bidders for these services, the ECB calls on qualified bidders to express their interest in participating in the tender procedure by submitting a comprehensive application in accordance with the rules set out below for the provision of works and related services for the construction of a mock-up façade for the new ECB premises, consisting of a complete building envelope such as façade erection works, roof works, provision of a supporting steel substructure including a concrete foundation, basic building services (e.g. electricity, rain water system) and optionally interior fit-out works.

Overall description:

erection of a sample high rise glass façade (2 floors) consisting of various façade types in a complex geometry (as described below) as part of a complete building envelope (building mock-up) mounted on a raised steel structure. The 2 building levels will be accessed via a steel stair.

The structure and enclosure should prove the possibility for further completion works (interior fit-out works as sample rooms). The fit-out works will be an optional part of the herewith described construction measure. Supporting steel structure:

the supporting steel structure mounted on a concrete foundation will provide a table construction to elevate the 2 enclosed levels, stiffened by diagonal bracing, and a frame structure with stiff corners for the 2 enclosed levels. The floors will be made up by trapezoidal metal sheets covered with a levelling layer to provide a walkable surface.

Façade works:

the façade works include the full enclosure of the building, consisting of 3 different types of sample façades in different complex geometries (HP ('hyperbolic paraboloid') surface, inclination) and the corresponding façade joints, as well as further enclosures of the building, such as roof, underside and vertical opaque enclosure with door openings.

Further Works and services:

the further works include:

- preparation and installation of the construction site,

- a steel stair providing vertical access,
- electric installations (e.g. for light as well as an electric heating system),
- rain water installations,
- concrete works,
- sealing works,
- optional: interior fit-out works (e.g. walls, doors, suspended ceilings, floors).
