Since the introduction of the euro as a currency, the ECB has entrusted laboratories to analyse and monitor the presence and concentration of certain substances with a potential impact on health and safety in euro banknotes and their raw materials (paper, inks, foil and threads). Based on the above, the present procurement procedure concerns the chemical analyses of the presence and concentration of certain specified substances (about 345 in total) in paper-based matrixes (euro banknotes and banknote raw materials).

It is estimated that several samples will be provided to contracted laboratories to be analysed with regard to the presence and concentration of specified substances. The contracted entities will be required to perform analysis using in-house or specified methods. The results shall be reported in 2 ways:

- a) the figures related to concentration and limit of detection (LOD); and
- b) information on the analysing process, methods used, special observations, etc., both based on templates provided by the ECB.

As it is expected that the list of substances may not be potentially covered by a single laboratory, the ECB intends to enter into framework agreements with several entities. The analyses for each substance will be contracted to 2 laboratories for the purpose of cross-checking the analysis.

If, however, the number of candidates meeting those minimum requirements exceeds 50, the ECB shall select those 50 candidates which best meet the following selection criteria:

- (a) the number of different substances that candidates have analysed (in routine analysis) during the last 3 years (30 %);
- (b) the number of samples that candidates have analysed during the last 3 years (30 %);
- (c) the number and scope of comparable reference projects executed within the last 3 years demonstrating the candidate's experience with the analysis of different matrixes (40 %).

For the purpose above, the ECB shall evaluate the applications using a scoring system of 100 points. The maximum number of points achievable per criterion is equivalent to the percentage weightings allocated to the selection criteria. The highest number provided for (a) and (b) will obtain the maximum score per criterion and the others proportionally less (30-30 respectively). The criterion (c) will be assessed on the basis of a scoring system from 0 to 5 points, taking into account all reference projects listed by the candidate as provided for in Section 3.5 of the application form. The list of reference projects demonstrating the highest quality shall obtain the maximum score (40) and the others proportionally less.
