# II.1) Description

# II.1.5) Short description of the contract or purchase(s):

The European Central Bank (ECB) tenders the preliminary works for the construction of the new ECB premises to 1 contractor. The works and services to be provided comprise demolition works, excavation for the pit, sheeting works, foundation piles of the high-rise building, as well as parts of the related execution planning. The new ECB premises will be built on the site of the former wholesale market hall in the eastern part of

D-Frankfurt-on-Main (Sonnemannstraße). The site comprises approximately 120 000 m<sup>2</sup>.

- chapter 1 works for the pit and sheeting,
- chapter 2 construction of the foundation piles of the high-rise building,
- chapter 3 demolition of the annex buildings of the wholesale market hall,
- chapter 4 demolition of the south ramp of the wholesale market hall,
- chapter 5 disposal of contaminated building material of the annex buildings of the wholesale market hall,
- chapter 6 special requirements of the monument preservation authority,
- chapter 7 execution planning and management.

Transportation and disposal of soil will be provided by another contractor tendered in parallel (tender 081).

The successful tenderer will be paid in accordance with a payment plan. The payment plan will foresee appropriate security retention (up to 10 % of the payment) which can be exchanged against the performance guarantee mentioned in point III.1.1 above. Details will be given in the ITT.
