1. Overview

The <u>SCoRE Adaptation Plans Status Report (published 21 July 2020 on ECB</u> website) provides an overview of Adaptation Plans in AMI-SeCo markets.

The <u>SCoREBOARD</u> "First Compliance & Progress Report" (published June 2020 on ECB website) covers the progress in defining, and assessing compliance with, the Single Collateral Management Rulebook for Europe (SCoRE).

- Adaptation Plans have been provided by the majority of AMI-SeCo markets by CSDs and TPAs, and the plans demonstrate a clear roadmap for achieving compliance with the AMI-SeCo Standards. There are separate plans for Triparty Collateral Management, Corporate Actions, Billing Processes.
- The SCoREBOARD shows progress has been achieved in the implementation of the AMI-SeCo Standards.
