## Message overview (1)

Messages used by the future RTGS, CLM and sharable components Categories

- 1. ISO message (no CR needed)
  - Available ISO (equivalent) message for which no CR is needed according to current status of investigations
- 2. ISO message (CR needed)
  - Available ISO (equivalent) message for which a CR is needed according to current status of investigations
- 3. New ISO message
  - No ISO (equivalent) message available, so a new ISO message has to be drafted and registered
- 4. Proprietary message
  - Available proprietary message to be used for CB business or ASI SP 4-6 only

Provided list of messages reflects the current status (see separate document)



#### **Message overview (2)**

#### Info on message HEAD.002

- Files can be sent to the RTGS service
- Messages received in one file
  - will be separated and then treated as single messages
  - will be answered by a single message (e.g. PACS.002) for each provided incoming message



#### **Usage of MyStandards (1)**

- Currently the only Message drafting group is shown
- Finally, all different services (e.g. RTGS, CLM, T2S) will be accessible via EMIP group
