The five substreams of the CMH-TF will explain the conclusions of their discussions on barriers to efficient collateral management and proposals for harmonisation. The tables prepared by the substreams will be included in the draft report, and CMH-TF members are invited to review the specific barriers and proposals for harmonisation. Substream leads will explain the substream suggestions for prioritisation of harmonisation activities/business processes.

- Substream 1: Triparty Collateral Management (lead: Clearsteam);
- Substream 2: Corporate Actions, Taxation Forms, Non-Euro Collateral Management (lead: Citi);
- Substream 3: Bilateral Collateral Management, Margin Calls (lead: BNPP);
- Substream 4: Fee and Billing Processes, Reporting, Cut-Off Times (lead: Monte Titoli);
- Substream 5: Collateral Dynamic and Static Data (lead: Deutsche Bank).

2.2. Interdependencies of harmonisation proposals

CMH-TF members are invited to consider possible interdependencies of the proposals for harmonisation also for the next steps towards implementation (e.g. documentation of the business processes, identification of data elements necessary for the functioning of this process and/or the definition of ISO 20022 message for the transmission of the required data elements).

CMH-TF members are invited to consider the overall priorities in relation to each other (consider the main priority items from across the substreams).

2.4. Main conclusions of the report

CMH-TF members are invited to discussion the overall main conclusions of the report on collateral management harmonisation.
