Collateral Management Harmonisation Activities (CMHAs)

Introduction

HSG had a first discussion (8-9 June 2017) on integration and efficient functioning of collateral management.

- 1. <u>Key areas of work</u>: Identifying key activities on collateral management that could merit further work on harmonisation (similar approach as T2S harmonisation).
 - A preliminary list of CMHAs (will have to be explored in more detail in particular on the problem areas).
 - Impediments are related to operational barriers (other barriers, such as legal and regulatory issues, are covered elsewhere).
- 2. Envisaged next steps: Task Force of HSG.

AMI-SeCo is invited to take note of the HSG's status update.

1. Key areas of work

Key areas:

- Messaging (Collateral messaging)
- Data (Collateral dynamic and static data)
- Collateral operating framework (business processes)
- Non-euro collateral (Procedures for non-euro collateral)

List of Activities

HSG aim: first list of concrete harmonisation activities by Q4 2017.


- List should be derived from problems/barriers.
- Cover messaging and business processes.
- Some activities may not be collateral management specific, but be related to standard settlement/custody.
- Of relevance for wider community (unless strong and commonly agreed business justification).

2. Envisaged next steps – dedicated HSG task force

Proposed set up of a HSG task force on collateral management harmonisation (CMH-TF)

- Call for expressions of interest (by 28 July 2017).
- Aim of CMH-TF:
 - to deepen the analysis of the HSG's initial deliberations on collateral management harmonisation
 - with a view to making a concrete harmonisation proposal to the HSG by Q4 2017
 - thereby taking into account earlier/ongoing harmonisation efforts
- Expertise:
 - Strong and detailed expertise in collateral management and standard settlement and custody processes
