Releases 3.x (June 2019 - June 2020)

• Release 3.0

- Deployment: 8 June 2019
- CR scope : 12 CRs, including:
 - Upgrade of T2S messages to ISO 20022 Maintenance Release 2017
 - CRs enhancing the information included in status updates and other T2S messages
 - Introduction of the 'buy-in' transaction type, enhanced reporting of settlement finality timestamps

Release 3.1

- Deployment: 21 September 2019
- Scope: Fixes for production problems

Release 3.2

- Deployment: 15 November 2019
- CR scope: 6 CRs, including:
 - Additional bundling of T2S messages
 - Partial release functionality
 - Extension of 2 partial settlement windows (effective 9 December 2019)
 - Introduction of status 'Failing'
 - Consistent reporting of 'Place of trade' and 'Place of clearing'

• Release 3.3

- Deployment: 15 February 2020
- Scope: Fixes for production problems

- Deployment 13 June 2020
- CR scope : 6 CRs approved + 1 CR ongoing detailed assessment (DA) :
 - CR-671 (Storage and reporting of the Beneficial Ownership indicator for Settlement Instructions in T2S)
 - CR-677 (During partial settlement windows, recycling should only be triggered after an optimization attempt)
 - CR-668 (Provide the T2S reference of the linked instructions preventing settlement)
 - CR-689 (New process to maximise settlement of transactions at DVP cut-off)
 - CR-658 (Already matched instructions with deviating settlement parameters on DELI/RECE legs)
 - CR-719 (Common Reference Data Management for T2-T2S Consolidation Modified Objects)
 - CR-722 (Upgrade of non-repudiation for U2A mode) (DA ongoing)

Release 4.1

Release cancelled in order to allow more testing time for R4.2

Release 4.2

- Deployment 21 November 2020
- Context: Entry into force of the CSDR settlement discipline regime end 2020
- CR scope : 8 CRs allocated + 2 CRs ongoing detailed assessment
 - CSDR Penalty mechanism (CR-654, CR-715, CR-718)
 - Upgrade of T2S messages to ISO 20022 Maintenance Release 2019 (CR-713) + other CRs with message impacts (CR-684 & CR-695)
 - 4 T2S CRs related to T2-T2S Consolidation (CR-702, CR-703 approved; CR-698, CR-721 DA ongoing)

Release 4.3

- Deployment 20 February 2021
- Scope: Fixes for production problems

Releases 5.x (June 2021 – June 2022)

- Context: T2-T2S Consolidation go-live November 2022
- Release 5.0
 - Deployment 12 June 2021
 - CR scope: 9 CRs ongoing detailed assessment
- Release 5.1
 - Deployment 18 September 2021
 - Scope: Fixes for production problems
- Release 5.2
 - Deployment 20 November 2021
 - CR scope potentially includes (tbc by detailed (re-)assessments):
 - Additional haircuts for own-use collateral and other auto-collateral related CRs
- Release 5.3
 - Deployment 19 February 2022
 - Scope: Fixes for production problems

Releases 6.x (June 2022 - June 2023)

- Context: ECMS go-live November 2022
- Release 6.0
 - Deployment 11 June 2022
 - CR scope potentially includes (tbc by detailed assessments):
 - 5 CRs related to T2-T2S Consolidation, including the migration of T2S to the new connectivity layer ESMIG
- Release 6.1
 - Deployment September 2022
 - Scope: Fixes for production problems
- Release 6.2
 - Deployment November 2022
- Release 6.3
 - Deployment February 2023
 - Scope: Fixes for production problems

<u>T2S-0520-SYS</u>	Add new fields to T2S messages sese.020, sese.024 and sese.025 needed for CA processing
<u>T2S-0542-SYS</u>	Enrich the Bank To Customer Debit/Credit Notification (camt.054) with data elements securities account Owner Parent BIC and securities account Owner Party BIC
<u>T2S-0543-URD</u>	Minimum amount for auto-collateralisation transactions
T2S-0587-SYS	Alignment of ISO transaction codes across various T2S ISO messages
T2S-0590-SYS	Include information from the underlying settlement instruction in the T2S 'Bank to customer statement (camt.053)' and in the T2S 'Bank to customer debit credit notification (camt.054) messages for Settlement, Custody/Asset servicing and Reconciliation
T2S-0600-SYS	T2S reporting functionality must be enhanced to allow the retrieval of the settlement instructions and their related SF1 (accepted) /SF2 (matched) timestamps via A2A/U2A in an efficient and standard way
T2S-0607-SYS	T2S must be able to identify, store, and report settlement information related to buy-in transactions consistently across T2S messages
T2S-0612-SYS	Alignment of T2S Messages with ISO Maintenance Releases 2013 - 2017

T2S-0606-SYS	T2S should maintain and report information related to 'Place of Trade' and 'Place of Clearing' of a settlement instruction consistently across T2S messages
T2S-0609-SYS	T2S must be able to report settlement status 'Failing' for settlement instructions for which settlement at the Intended Settlement Date (ISD) is no longer possible
T2S-0613-URD	T2S should give the possibility to receive outbound T2S messages bundled in files
