Proposed wording for the Change Request:

The CR proposes to change the subsection heading to reflect properly the requirements for cash balances that the section will document through moving the cash balance query requirements to section 14.5.1..The CR proposes to delete requirements T2S.14.810, T2S.14.820 and T2S.14.825 and to replace it with one query requirement T2S.14.811 in the renamed subsection 14.5.1 as documented below:

Queries will be processed in real time, based on the latest cash balance available. During night-time settlement cycle runs, queries on a dedicated T2S cash account will return an error message indicating that no information can be provided at the moment because a settlement cycle is in progress.

3. Addition of requirement T2S.14.811 for cash balance query

Cash balances

Reference ID	T2S.14.811

T2S shall provide NCBs, settlement banks and payment banks, in accordance with their access rights, with the possibility to query the current balance of one or more T2S dedicated cash accounts.

The query shall support the following selection parameters for payment banks and settlement banks:

- a specific NCB;
- a specific T2S party (Settlement bank, payment bank);
- a specific T2S dedicated cash account;
- a T2S settlement currency.

The query shall support an additional parameter as NCB, which allow the NCB to query all balances of all T2S dedicated cash accounts for which it is responsible. The parameter will specify whether the NCB acts in its capacity as central bank or T2S party.

The query shall return the following information:

- T2S party (settlement bank, payment bank);
- T2S dedicated cash account;
- debit/credit indicator
- current balance;
- sum of blocked balances;
- sum of reserved balances;
- available balance (current balance (sum of blocked balances + sum of reserved balances))
- date and timestamp of balance;

Examples and further descriptions regarding the cash balance query:

- If the query specifies a T2S party and no T2S dedicated cash account, then the query result shall include the balances of all T2S dedicated cash accounts of the party.
- If the query specifies a T2S party and a T2S settlement currency without a T2S dedicated cash account, then the query result shall include the balances of all T2S dedicated cash accounts of the party in the specified currency.
- If the query specifies a T2S dedicated cash account, then the query result shall be the cash balance of the specified T2S dedicated cash account.
- If the query specifies a T2S party that is an NCB, and the NCB has specified in the query parameter that it is querying in its role as NCB, then the query result will provide the balances of all T2S dedicated cash accounts of the T2S parties, which hold accounts with it.
